Container Glass Industry – Present & Future

The global container glass market size stood at 63.7 USD billion in 2021 and is anticipated to reach USD 82.2 billion by 2028 at a CAGR of 3.7% from 2021 to 2028. The global glass market is predominantly driven by the increasing demand for Alcoholic Beverages, Food and Pharmaceutical. Asia-Pacific excluding the Japan (APEJ) has the largest demand market, followed by Europe and the Americas. In terms of production too, APEJ is the major producer and exporter of glass containers followed by Europe.

The Asia-Pacific region is expected to register a significant growth rate compared to other nations owing to an increase in demand for pharmaceutical, alcoholic drinks and chemical industries, which prefers glass packaging because of the inert nature of glass bottles. China, India and Australia among others are the prominent nations majorly contributing to the growth of the Asia Pacific glass packaging market.

Russia - Ukraine War & COVID-19 Pandemic- Russia- Ukraine war has caused steep rise in energy and raw material cost. Supplies from Ukraine has halted whereas with Global sanctions and ban on purchase from Russia has worsened the business economics. Various sanctions are already imposed or under consideration on Russian gas, Crude Oil, Coal, Russian bank, swift transaction, Russian Ships etc. EU, USA and allies are gradually phasing out import of crucial goods from Russia and want other nations to align with their strategy. Private multi-national companies are also pulling out and disengaging with Russia. This all has led to supply chain disruption of crucial goods of glass industry. Although the world and manufacturing industries have learnt to continue production in COVID pandemic, its business impact is still being felt. Both these have impacted the growth trajectory of Glass Packaging industry due to supply chain disruption, intermittent lockdown and imposition of restriction.

Revenue of the global **food industry** jumped by 20%, reaching \$8.2trn in 2020 and it reached 8.27 trillion USD in 2021, an increase of over 500 billion USD. Food revenue worldwide will continue to increase and reach around 11.1 trillion USD in 2027. Glass packaging growth trend in **Cosmetic and Fragrance** has taken a hit. **Pharmaceuticals segment** witnessed remarkable growth and it is expected to portray the largest CAGR of 7.5% from 2021 to 2030. Due to increase in severity of diseases there is upsurge in adoption of container glass for storage and packaging of pharmaceuticals.

Premium Food & Beverage brands mostly prefer container glass over other packaging options such as plastics, as glass is sustainable, chemically inert, non-porous and impermeable.

Some of the factors of Container Glass Industry which limits the growth perspective are volatile prices of Energy and Raw materials, Higher Logistics costs, Issues of Breakage and Growing use of Alternate Packaging like Plastics, Paper and Flexible packaging etc.

Indian Container Glass Industry

Due to COVID pandemic, Total size of India container glass Market shrunk by approx. 15% in FY21 to 5,100 Cr from 6,000 Cr in FY20. However, FY 22 witnessed market recovery and revenue touched Rs 5,800 Cr. Indian Glass Industry is expected to grow at 6.8% CAGR to 8,600 Cr by FY 28. Current running capacities are in tune of 29.5 Lacs MT and it is likely to grow at 3.5% CAGR up to FY27 despite the small aberration caused due to COVID-19 pandemic. All the players are likely to take



cautious approach towards capacity expansion due to bitter experience in the past which led to abnormally high excess capacity.

Beer and IMFL segment have come out of blue and is expected to remain buoyant in FY23. Food and Pharma segment surge is expected to continue. Union Budget Healthcare allocation of Rs 86,200 Cr will further boost Pharma segment.

Capacity Utilization are likely to improve in coming times, however profitability of the container glass player is critically dependent upon crude oil prices and raw material Cost which hit the roof and adversely impacted glass industry in FY22.

New Opportunity- Plastic Recycling Norm, Light Weight Bottle, Pharmaceutical Industry Growth & Milk Industry

Environment ministry has notified comprehensive guidelines on Extended Producer Responsibility (EPR) for plastic packaging which requires the Producer shall ensure minimum level of recycling of 70% in FY 2022-23 (as compared to 25% in 2021-22) and 100% in 2023-24. This stringent norm imposed on plastic producers is a big opportunity for glass industry in India as customers are expected to switch from plastic to glass for substantial packaging quantity to meet their packaging requirement as this norm may lead to dearth of plastic supply.

Besides increasing awareness about the hazards of using alternate packing like PET/Plastic bottles among the public as well as among the government institutions, this Pandemic of COVID-19 has also showcased glass as the best suited packaging alternative to various segments producing health and wellness products. Due to pandemic and its repetitive waves, for the time being Government initiative of banning plastic has gone into the backburner, however once normalcy is fully restored, it is expected that ban on plastic bottle in phased manner by the Government will again pick up the momentum. Many companies in the past has shown interest to switch its packaging from PET to Glass Bottles. Emergence of lightweight container glass products creates new opportunities in the coming years.

India Pharmaceutical industry has been growing at rapid pace and in this times of pandemic, momentum has further picked up. Globally India is now being talked about as the pharmacy of the world. Life-saving drugs and promotion of Pharmaceutical products would provide for good growth in Pharma segment.

The global dairy industry has been witnessing a backward shift from plastic to glass bottles. Driven by consumer demand for environmentally friendly milk, many small dairy market players choose to sell their products in reusable bottles. Indian Glass Industry should also unitedly promote glass packaging of milk and run massive campaign, which is supposed to open new avenues for glass industry over time.

Challenges

- 1. **Russia- Ukraine War:** Russia and Ukraine are the key suppliers of raw materials that run the worlds of oil, gas energy and metallurgical industries. The Russia-Ukraine war has halted supplies from Ukraine, led to a ban on purchases from Russia and heightened economic woes of the COVID-rattled world. This is heavily impacting crude oil and raw material prices related to glass industry.
 - Key input material prices have witnessed steep increase, which might enforce container glass industry to increase bottle price.
- 2. **Soda Ash** Prices have skyrocketed in the span of 6 months and its price has more than doubled and its inching towards becoming triple. Soda Ash constitutes more than 60% of raw material cost and with more than two-fold increase in price; glass industry production cost is hitting the roof. There is no sign of respite for now and Soda ash price is expected to shoot up further.

- 3. Uncertainly in **Crude Oil** prices and its direct impact on Power and Fuel cost in Glass industry Brent crude oil price rose from 37.5 \$/bbl in Oct20 to 66.5 \$/bbl (in Apr-21). However, during FY22 it saw **continuous leapfrog jump** and lately it skyrocketed due to Russia-Ukraine war and touched **112.4 \$/bbl**. This is true for all other grades of crude Oil as well. Glass industry being energy-intensive industry, it is posing serious challenges for the coming times as well.
- **4. Indian Rupee** has depreciated significantly during last 4 months due to crude oil price rise and global supply uncertainty arising post Russia-Ukraine war. It reached value of Rs 76.2/ USD in April 22 from Rs 74.5/ USD in Dec21. It has direct bearing on the import of all chemicals and commodities.

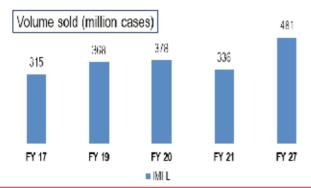
Threat

- 1. Threat from alternate packaging like PET, Multilayer Brick, Metal Cans, etc.
- 2. Domestic Soda Ash players RSPL, GHCL & DCW keep filing for Anti-Dumping Duty (ADD) imposition against soda ash Imports from Turkey & USA and Anti-Subsidy Duty imposition on Soda Ash against Turkey. Soda is one of the key ingredient for glass bottle production and any imposition of ADD & Anti- subsidy will have direct impact on Company bottom line. The worst part is they take stay order from court once DGFT disapprove ADD imposition and continue to charge premium price.

Sectoral Analysis

Liquor

The country's alcohol industry is on the road to recovery from the Covid-induced slump of 2020, and touched 345-million



cases pre-Covid sales by the end of this fiscal. Liquor segment is expected to have 6.8% CAGR for upcoming 6 years.

Diageo, the maker of Johnnie Walker and McDowell's whisky, saw its Indian business grow 12% while rival Pernod Ricard, maker of Absolut vodka and Chivas Regal Scotch, said sales expanded 19% during the second half of 2021. Bacardi India, which sells Bacardi rum and Dewar's Scotch, saw a 30% growth in India in 2021, one of its highest sales expansions.

There is a tilt toward innovative offerings and premium products. As the pandemic pushed people to live it up,

they were ready to embrace quality and experimentation. The industry also responded to this sentiment with ready-to-drink beverages, new flavour profiles or even smarter packaging with mixers or accessories. The emergence of Indian craft gin earlier and now the RTD segment is witnessing brand launches with diversified offerings. Consumers are experimenting with experiences beyond the pure functional benefit of alcohol which, besides adding new consumers to the alcohol category, accelerates social acceptance of alcoholic beverages as a normal consumer product. Liquor companies are launching variants targeted at women consumers. There is a strong trend of openness among women towards alcoholic beverages and is seen as an important pillar of growth. Women prefer less strong drinks, sweeter and softer whiskies.

Taxation and duties (which vary in every state) in India is on an average between 50% and 60%, the highest in the world. It is highly solicited that states should rollback increase of excise tax which was imposed to sustain tax collection during COVID period.

India remains a whiskey drinking country and consumers prefer drinks made here because of relatively low price tags. Companies, however, are selling more premium drinks aided by a new class of drinkers with more disposable income.

Since Diageo acquired USL more than five years ago, the contribution of the premium segment to its overall sales has gone up to two-thirds from 45-50% in 2014.

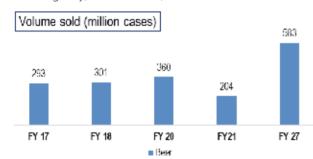
Alcohol consumption in India has doubled in the last 25 years. Focus is going to be more on premium segment apart from increased penetration of routine category to increase per capita consumption in India.

Share of glass packaging in IMFL is expected to increase due to following factors.

- 1) Premium segments which constitute more than 40% of IMFL volume uses 100% glass packaging. The share of this segment is expected to grow to 67% of volume by 2027 and hence the overall share of glass packaging in IMFL will also increase.
- 2) In the Mass / Popular segment, the share of glass bottles has reduced due to emergence of cheap alternate PET bottles. However, revenue leakages and ill effects on health are forcing state governments to turn back to glass packaging in liquor in phased manner.

Beer

India's beer sales by volume expanded to a decade high in 2021 due to the low base, gradual recovery in restaurant & bars & surging at-home consumption. It grew **28%** last calendar year, according to the latest data by Global-Data, a UK-based research agency, while In 2020, the beer market shrunk 40%.



Anheuser-Busch InBev (ABI), which owns Budweiser saw strong double-digit growth in volume and revenue last calendar year with an even higher growth in EBITDA that was above pre-pandemic levels. Heineken, the world's second-biggest brewer Indian business grew in the thirties while Danish brewer Carlsberg, Indian business posted more than 30% volume growth in calendar 2021 but remained below 2019 level. From FY23 onwards it is expected that beer market will grow at a CAGR of 10%.

Beer companies are on tenterhooks as there could be a steep increase in prices of barley and disruption of supplies on account of the **Russia-Ukraine crisis**. Ukraine is among the top five global producers of barley and global supply is already getting effected. Barley prices have escalated quite significantly and Ukraine will definitely impact global barley pricing in the short to medium term. The period between March and July accounts for 40-45% of annual beer sales, and barely is the mainstay ingredient used in beer.

The lockdown and subsequent changes in various policies related to distribution and opening up saw changes in consumption and sales patterns. Consumption patterns, too, saw a shift with consumers diversifying their choices and expanding their palate horizons. This has also resulted in a sharp rise in demand for our premium offerings.

Alcobev companies warned rising input costs could force them to take price hikes, which in turn could hit demand, especially for beer. While globally, beer is taxed on alcohol strength, in India, it is taxed on alcohol by volume, which makes beer more expensive than spirits. However, Looking ahead to the summer, there is optimism as consumer confidence is returning with the decline in COVID cases and the complete reopening of the on-trade channel.

South India accounts for the largest market share of the India beer market due to hot weather condition. North India and Western India are expected to be the fastest growing markets. Drinking in bars is fast becoming a social phenomenon in Metro and Tier 2 cities and same is leading to increased beer consumption. Besides, the rising number of pubs and bars are another factor which increase beer consumption.

The beer industry has seen various merger and acquisition in India which has consolidated the Market place and lead to increased Market competition during the last five years which has led to deep market penetration. In 2021, Heineken NV, the world's second largest beer maker, has taken control of India's largest brewer United Breweries Limited (UBL), cementing its position in a vast market where beer consumption could grow from a low base. US-based Molson Coors Brewing Company acquiring Mount Shivalik Breweries (Thunderbolt beer manufacturer), Ab InBev acquisition of SAB Miller in 2016. All Leading companies are increasing their manufacturing footprints to ensure product availability to its customer and increase in their market share. Carlsberg and Som distillers have put up capacities in East to increase their penetration in this zone.

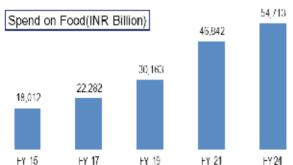
The potential for beer growth in India is strong with emergence of Craft Beer which is expected to grow at 108%. B9 Beverages & Simba is leading player in this segment. In January 2021, Kirin Holdings announced an investment of \$30

million in New Delhi-based B9 Beverages, the maker of the Indian craft beer Bira. The fresh funding indeed boosted Bira 91's confidence and growth plan. In Aug-21 Bira 91 announced that they are planning to set up a new brewery in India. In Apr-22, Bira 91 has launched a portfolio of four limited release flavours. The 'Imagined in India' portfolio includes beers crafted with indigenous ingredients. B9 Beverages with launch of Bira Craft Beer about five years ago, has managed about 5% share in key markets despite the dominance of MNC players.

Share of glass packaging in Beer is quite high i.e. ~ 85% and is likely to continue in the future also. Reuse of Old bottles are likely to reduce going forward as the market is mainly led by MNC players. Increase in Manufacturing footprints leads to Increased creation of Glass pool, which ultimately increased Glass bottle demand.

Food

The Indian food industry is continued its growth trajectory and reach \$645.8bn value in CY 2021, a 2% increase year-over-year despite the massive growth of 36% witness in CY 2020.



Statistics show the Indian food industry is expected to continue growing at brisk pace. It is expected to grow at CAGR of 7.2% till FY24. HUL FY22 3rd Quater, Net Profit rises by 16.8% YOY to Rs 2,243 Cr and has 10.4% growth in revenue where Q2 witnessed 8.86% increase in Net profit. For the year 2021, Nestle India's net profit was up 3 per cent to Rs 2,144.86 crore, as against Rs 2,082.43 crore a year ago. Its revenue from operations increased to Rs 14,709 crore in 2021, from Rs 13,350 crore in 2020.

FY 15 FY 17 FY 21 FY 21 India's ready-to-cook food sales rise since the onset of pandemic. It saw brisk sales as people ordered in a variety of foods. Covid-19 has had a positive impact on organised packed food brand business. The positive shift to organised branded and packed food has already begun and this shift is going to be irreversible

Evolving consumer preferences, rising income, growing rural opportunity, digital channels & E-commerce, Improved Retail chain and customer preference for home delivery has given further impetus to this segment. In 2021, Zomato Ltd. listed on the Indian stock exchanges at more than 50% premium to its issue price. Swiggy which was valued at \$10.7 billion in its Series K financing in Jan-22, is looking to raise as much as \$1 billion in the IPO, which it plans to file as early as the first half of next year.

In 2021 **Rs 10,900 Cr** PLI scheme got approved for the food processing. The government has sanctioned 37 food parks funded under the Mega Food Parks Scheme, 22 are operational and 15 are under implementation sector by the Union Cabinet will boost investment and fuel growth in the sector.

India's food processing sector is one of the largest in the world and its output is expected to reach US\$ 535 billion by 2025-26. There is growth in the organised food retail sector and increase in urbanisation. MSME's are playing a vital role in India's food processing chain through various advancements in skills and technology. The online food ordering business in India is witnessing an exponential growth. There is a shift in focus from loose to branded packaging. The government's 'Atmanirbhar Bharat' initiative places priority on this sector and offers support through various policies. By 2024, the Food Processing industry will potentially attract \$33 bn investments and generate employment for 9 million people. By 2025, India's food processing sector is expected to be worth over half a trillion dollars. By 2030, Indian annual household consumption is to treble, making India 5th largest consumer.

The Indian FMCG industry witnessed a consumption slowdown in urban markets and de-growth in rural areas in 2021, as the sector was hit hard by higher inflation levels forcing companies to go for successive price increases. However, In the last two years, 8 lakh new FMCG stores were added and more than half of that has come into the rural area. This pace of opening new stores is more than double of the pre-COVID years.

The Indian organic food market has also seen a surge with a market size touching \$820 million in 2020, which was just about \$200 million in 2018, as per the report, and is likely to grow at a CAGR of 24% during 2021-2026 and will reach a value of US\$ 2,601 Million by 2026.

The dairy market in India reached a value of INR 13,174 Billion in 2021. Looking forward, IMARC Group expects the market to reach INR 30,840 Billion by 2027, exhibiting at a CAGR of 14.98% during 2022-2027.

Along with offering profitable business opportunities, the dairy industry in India serves as a tool of socio-economic development. The private participation in the Indian dairy sector has also increased over the past few years.

The organised dairy industry is likely to witness 12 per cent revenue growth this financial year to reach Rs 1.6 lakh crore, mainly due to recovery in demand for value-added products (VAPs), steady liquid milk sales and a hike in the retail price.

Amul has planned to invest Rs 5,000 crore over next five years. Amul has recently announced the setting up of their largest state-of-the-art plant in Telangana with an investment of Rs.500 crore. Both national and international players are entering the dairy industry, attracted by the size and potential of the Indian market. The focus is being given to value-added products such as cheese, yogurt, probiotic drinks, etc. These players are also improving their milk procurement network which is further facilitating the development of the dairy industry in India.

Share of glass packaging in food segment is $\sim 10\%$ and in dairy is $\sim 15\%$ and is not expected to change significantly in future, though it is the most preferred choice for premium milk shakes, yogurts and flavoured milk. Government is pushing the food processing segment aggressively and taking all needful measures to provide impetus to this segment. This will ultimately lead to increase in Glass bottle demand. **COVID-19 pandemic** impact has further grew awareness for usage of glass packaging in health products.

Pharmaceuticals

The pharmaceutical industry in India was valued at an estimated US\$42 billion in 2021. India is the world's third largest provider of generic medicines by volume, with a 20% share of total global pharmaceutical exports. It is also the largest vaccine supplier in the world by volume, accounting for more than 50% of all vaccines manufactured in the world. The Indian pharma industry has shown a double digit growth of around 15% in CY21 led by growth of Covid-19 products in the last one year. The Indian pharma industry is estimated to grow at 9-11 per cent in 2021-22 and in the next few quarters, it will be driven by domestic and emerging markets. The pharmaceutical industry in India is expected to reach \$65 bn by 2024 and to \$120 bn by 2030. Sun Pharma FY22 - Q3 Profit jumps 11% YoY whereas in Q2 it rises by 13%. Dr Reddy Laboratories has revenue jump of 8% in FY22 - Q3.

Government has introduced a US\$2 billion incentive program which will run from 2021-22 to 2027-28 to foster an Atmanirbhar Bharat by enhancing the R&D, Make in India product development, high-value production capabilities, import substitution and domestic manufacture of active pharmaceutical ingredient (API), the

In terms of the global market, India currently holds an accountable share and is known as the pharmacy of the world and as the biggest generic supplier. India gained its foothold on the global scene with its innovatively-engineered generic drugs and active pharmaceutical ingredients (API), The country accounts for around 30 per cent (by volume) and about 10 per cent (value) in the US\$70–80 billion US generics market. Growth in other fields notwithstanding, generics are still a large part of the picture. India is the largest provider of generic drugs globally. The Indian pharmaceutical-sector industry supplies over 50 per cent of global demand for various vaccines, 40 per cent of generic demand in the US and 25 per cent of all medicine in the UK. India is the largest contributor in UNESC with over 50-60% share.

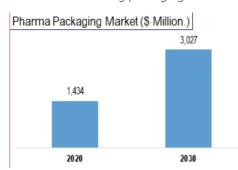
According to the Economic Survey, a significant raw material base and availability of a skilled workforce have enabled India to emerge as an international manufacturing hub for generic medicines. Further, India is the only country with the largest number of US-FDA compliant pharma plants outside of the USA

Covid-19 has presented both an opportunity and a challenge for India to emerge as the 'pharmacy of the world'. The commitment of provision of Covid-19 vaccine to other countries has made India the epicentre for its manufacturing

India's cost of production is significantly lower than that of the US and almost half of that of Europe. It gives a competitive edge to India over others. Increase in the size of middle class households coupled with the improvement in medical infrastructure and increase in the penetration of health insurance in the country will also influence in the growth of pharmaceuticals sector.

Indian pharma companies are capitalising on export opportunities in regulated and semi-regulated markets. In FY20, India exported pharmaceutical products worth US\$ 20.5 billion which in FY21 & FY22 hovered around \$24.5 billion

The India pharmaceutical packaging market was valued at \$1434 million in 2020, and is projected to reach \$3027. million by 2030 at a CAGR of 7.54% from 2021 to 2030 driven by growth in pharma industry and its need for bulk drugs, formulations, Vaccine and trial drug packaging.



Share of glass packaging in liquid formulations is still high given potential risks of storing medicines in plastic bottles.

However, overall share of glass packaging came down from 34% in 2009 to around 20% and is further expected to fall in future until government brings some regulation to curtail plastic usage in Oral formulations and Suspensions due to plastic ill effect. Some glass players in India are optimistic about phasing out of plastic usage.

Soft Drinks

Consumers' changing preferences, coupled with innovations in product packaging and sizing to improve affordability, has led to a rise in the consumption of non-alcoholic beverages in the country. In terms of revenue, the non-alcoholic beverages market in India was valued at INR 336.50 billion in FY 2020. It is expected to reach INR 1,131.52 billion by FY 2027, expanding at a compound annual growth rate (CAGR) of ~18.69% during the forecast period.

The non-alcoholic beverages market is categorized into two segments - carbonated and non-carbonated beverages. The carbonated beverages market segment was valued at INR 134.60 billion in FY 2020 and is expected to reach a value of INR 349.64 billion by FY 2027, expanding at a CAGR of ~15.12% during the FY 2022-FY 2027 period. The non-carbonated beverages segment in India was valued at INR 153.33 billion in FY 2020. It is expected to reach INR 781.88 billion by FY 2027, expanding at a CAGR of ~20.52% during the FY 2022-FY 2027 period. The carbonated beverages segment is anticipated to lose its market share during the forecast period because of the massive expansion of the non-carbonated beverages segment. Over the past few years, non-cola aerated drinks have gained popularity, especially fruit drinks.

With growing cost pressure and ease of use, Coca Cola and Pepsi are shifting their containers from glass bottles to PET bottles. Share of glass packaging has fallen from 34% in FY 09 to below 20% at present and is further expected to decrease.

Glass usage in CSD Business has witnessed a negative growth of 13%. This is continuation of its trend from 3-4 years and same is likely to continue.

Cosmetics

Indian Cosmetics Market was valued \$13 bn in FY20 and is forecasted to grow at double digit CAGR of 16.39% through FY26 to reach USD 29 billion by FY2026. In comparison, the global cosmetics market is expected to grow at 5.3% CAGR and will reach ~USD 463 billion by 2025. This means that by 2025, India will constitute 6.3% of the total global cosmetics market and become one of the top 5 global markets by revenue.

Emergence of online retail, rising awareness of beauty products, increasing premium on personal grooming, changes in consumption patterns, lifestyles and improved purchasing power among women are expected to boost the industry. The market will maintain healthy growth due to rising preference for specialised cosmetic products such as organic, herbal and Ayurveda products. Principal areas that are expected to grow include colour cosmetics, fragrances, specialised skin care and make-up cosmetics.

The Indian industry is growing rapidly at a rate of 13-18 %, more than that of US or European markets. Body care is the largest category and growing at about 4 % CAGR while colour cosmetics is expected to grow at 13%. The premium segment is expected to grow at 6.3% per annum.

Pursuant to the Order, the powers of the Board of Directors stand suspended and are vested with Mr. Girish Siriram Juneja (IP Registration No. IBBI/IPA-001/IP-P00999/2017-2018/11646), who has been appointed as Interim Resolution Professional (IRP) by the Hon'ble NCLT and later confirmed as a Resolution Professional (RP) by the Committee of Creditors (CoC).

RESULTS OF OPERATIONS AND THE STATE OF COMPANY'S AFFAIRS

During the financial year, your Company reported total income of Rs. 2,09,700 Lakhs in F.Y. 2021-22 compared to Rs. 1,89,895 Lakhs in F.Y. 2020-21. Your Company recorded an EBITDA of Rs.-10,914 Lakhs and a net loss of Rs.34,852 Lakhs during the year under review.

The financial position of the Company continues to be under severe stress. The situation further deteriorated, due to increase in Power & Fuel and Raw Material costs. Due to paucity of funds, your Company could not do any maintenance of capex and also failed to meet its debt obligation.

DIVIDEND & RESERVE

Your Directors do not recommend any dividend for the year ended 2021-22. Further, during the year under review, no amount was transferred to General Reserve

ISSUE OF SHARES

The paid up Equity Share Capital as at 31st March, 2022 stood at 17,91,07,130 i.e 8,95,53,565 equity shares of 2/- each. The Company has not issued shares with differential voting rights, nor has granted any stock options or sweat equity. As on 31st March, 2022, none of the Directors of the Company, hold instruments convertible into equity shares of the Company.

SUBSIDIARY COMPANY

As on 31st March, 2022, your Company does not have any Subsidiary Company.

TRUST SHARES

Pursuant to the amalgamation of Ace Glass Containers Limited with the Company, 21,41,448* shares and 13,68,872* shares having face value of 10/- each (corresponding to 1,07,07,240 shares and 68,44,360 shares having face value of 2/- each) were issued to HNG Trust and Ace Trust respectively. At present, HNG Trust & Ace Trust are holding 76,41,600 & 30,50,000 shares respectively. In terms of an undertaking given to the BSE Limited, the Company is required to make disclosures, pertaining to utilisation of proceeds of shares allotted to the said Trusts, until they are extinguished. Entire Shareholding of Ace Trust and 75,06,850 Shares of HNG Trust has been pledged in compliance of Corrective Action Plan (CAP), approved by the Joint Lenders Forum.

Shri Sanjay Somany (DIN:-00124538) was appointed as the Chairman & Managing Director of the Company by the shareholders at the 75th AGM of the Company to hold office till 31st March 2022. However, since the Company is undergoing CIRP w.e.f 21st October 2021, status-quo is being maintained and he continues to be the Chairman & Managing Director of the Company.

Shri Mukul Somany (DIN:- 00124625) was appointed as the Vice - Chairman & Managing Director of the Company by the shareholders at the 75th AGM of the Company to hold office till 31st March 2022. However, since the Company is undergoing CIRP w.e.f 21st October 2021, status-quo is being maintained and he continues to be the Vice - Chairman and Managing Director of the Company.

During the year under review, Shri Dipankar Chatterjee (DIN: 00031256) resigned from the position of Non-Executive Independent Director of the Company with effect from 26th July, 2021 due to his health and personal reasons.

Pursuant to Section 152(6) of the Act read with rules made thereunder and the Articles of Association of the Company, Shri Sanjay Somany (DIN: 00124538), Director of the Company retires by rotation at the forthcoming Annual General Meeting and being eligible offers himself for re-appointment. The Board (RP & Directors) recommends the re-appointment of Shri Sanjay Somany as Director of the Company. A brief profile of Shri Sanjay Somany along with requisite details as stipulated

under Regulation 36(3) of Listing Regulations and Secretarial Standard on General Meetings (SS-2) issued by the Institute of Company Secretaries of India (ICSI) are provided in notice forming part of this Annual Report.

Shri Ratna Kumar Daga (DIN: 00227746), Smt. Rita Bhimani (DIN: 07106069) & Shri Amal Chandra Saha (DIN: 00443348) are the Independent Directors of the Company.

The Company has received declarations from all the Independent Directors of the Company, confirming that, they meet the criteria of Independence, as prescribed under Section 149(6) of the Companies Act, 2013. DEBT MANAGEMENT

The continuous higher financial leverage and lower profitability plagued the financials of the Company during the last few years. The spread of Pandemic had further worsened the profitability of the Company as the operations and sales of the Company were significantly impacted.

To reduce the leverage, Company had been continuously exploring various options for raising funds through equity/debt instruments or enter into joint venture. The Company had entered into One Time Settlement (OTS) with the Lenders as per the agreement entered in September' 2018 and made a substantial payment of Rs. 772.10 crores i.e Rs. 550.02 crores for fund based facilities and Rs. 222.08 for non-fund based facilities, from the date of OTS Agreement till the date of initiation of CIRP through Promoter's infusion, Internal Accrual and Cutback by the Lenders.

Meanwhile, some of the lenders filed fresh applications before the National Company Law Tribunal (NCLT), Kolkata Bench under section 7 of the Insolvency and Bankruptcy Code, 2016 (IB Code) and subsequently CIRP was initiated in respect of the Company vide order of the Hon'ble NCLT, Kolkata Bench dated 21st October, 2021. An appeal was filed by one of the Promoter with Hon'ble National Company Law Appellate Tribunal (NCLAT), New Delhi against the said Order of Hon'ble NCLT which is pending before the Hon'ble NCLAT. The Promoters of the Company have also submitted proposal under Sec 12A of the IB Code for revival of the earlier OTS plan which is pending before the Committee of Creditors. At the same time, the proceeding under the CIRP is also going on.

IA. Nomination & Remuneration Policy

1. Introduction

The Company considers human resources as its invaluable assets. This policy on nomination and remuneration of Directors, Key Managerial Personnel (KMP) and other employees has been formulated in terms of the provisions of the Companies Act, 2013 and the listing agreement in order to pay equitable remuneration to the Directors, KMP and employees of the Company and harmonize the aspirations of human resources, consistent with the goals of the Company.

2. Objective and purpose of the policy

The objectives and purpose of this policy are:

- 2.1. To formulate the criteria for determining qualification, competencies, positive attributes and independence, for appointment of a Director (Executive/Non-Executive) and recommend to the Board, policies relating to the remuneration of the Directors, Key Managerial Personnel and other employees. This includes, reviewing and approving corporate goals and objectives relevant to the compensation of the Vice Chairmen & Managing Directors (VC & MD) and Executive Director (ED), evaluating the VC & MD's and ED's performance in light of those goals and objective and either as a committee or together with the other independent directors (as directed by the Board), determine and approve the VC & MD's and ED's compensation level, based on this evaluation and making recommendations to the Board, with respect to executive officer compensation and incentive compensation that are subject to Board's approval.
- 2.2. The policy also addresses the following items: Committee member qualifications; Committee member appointment and removal; Committee structure and operations and Committee reporting to the Board.
- 2.3. To formulate the criteria for evaluation of performance of all the Directors on the Board.
- 2.4. To devise a policy on Board diversity; and
- 2.5. To lay out remuneration principles for employees, linked to their effort, performance and achievement relating to the Company's goals.

3. Constitution of the Nomination and Remuneration Committee

The Board has constituted the "Nomination and Remuneration Committee" of the Board on May 20, 2014. This is in line with the requirements under the Companies Act, 2013 ("Act").

The Board has authority to reconstitute this Committee from time to time.

Definitions

'Board' means Board of Director of the Company. 'Directors' means Directors of the Company.

'Committee' means Nomination and Remuneration Committee of the Company as constituted or reconstituted by the Board, in accordance with the Act and applicable listing agreements and/or regulations.

'Company' means Hindusthan National Glass & Industries Limited.

'Independent Director' means a Director referred to in Section 149(6) of the Companies Act, 2013 and rules. 'Key Managerial Personnel (KMP)' means -

- The Managing Director or the Chief Executive Officer or the manager and in the absence, a Whole-time Director;
- The Company Secretary and
- iii. The Chief Financial Officer

'Senior Management' means personnel of the Company, who are members of its core management team excluding Board of Directors, comprising all members of management one level below the Executive Directors, including the functional heads.

Unless the context otherwise requires, words and expressions used in this policy and not defined herein, but defined in the Companies Act, 2013 and Listing Agreement, as may be amended from time to time, shall have the meaning respectively, assigned to them therein.

General

This policy is divided in three parts.

Part - A covers the matters to be dealt with and recommended by the Committee to the Board; Part - B covers the appointment and nomination and Part - C covers remuneration and perquisites etc.

This policy shall be included in the Report of the Board of Directors.

Part - A

Matters to be dealt with, perused and recommended to the Board by the Nomination and Remuneration Committee

The following matters shall be dealt by the Committee:-

a) Size and composition of the Board:

Review the size and composition of the Board, to ensure that it is structured, to make appropriate decisions, with a variety of perspectives and skills, in the best interest of the Company as a whole;

b) Directors:

Formulate the criteria determining qualifications, positive attributes and independence of a Director and recommending candidates to the Board, when circumstances warrant the appointment of a new Director, having regard to the range of skills, experience and expertise on the Board and whole will best compliment the Board;

c) Succession plans:

Establishing and reviewing Board and senior executive succession plans, in order to ensure and maintain an appropriate balance of skills, experience and expertise on the Board and Senior Management;

d) Evaluation of performance:

Make recommendations to the Board on appropriate performance criteria for the Directors.

Formulate the criteria and frame work for evaluation of performance of every Director on the Board of the Company.

Identify ongoing training and education programs for the Board to ensure that Non-Executive Directors are provided with adequate information, regarding the options of the business, the industry and their legal responsibilities and duties.

e) Board diversity:

The Committee assist the Board in ensuring Board, nomination process, with the diversity of gender, thought, experience, knowledge and perspective in the Board, in accordance with the Board Diversity Policy.

f) Remuneration frame work and policies:

Formulate the criteria for determining qualifications, positive attributes and independence of a director and recommend to the Board, a policy relating to the remuneration for the Directors, Key Managerial Personnel and other employees.

Formulate remuneration policy of the Company to ensure that:-

- (a) the level and composition or remuneration is reasonable and sufficient to attract, retain and motivate directors of the quality required to run the Company successfully;
- (b) relationship of remuneration to performance is clear and meets appropriate performance benchmarks; and
- (c) remuneration to Directors, Key Managerial Personnel and Senior Management, involves a balance between fixed and incentive pay reflecting short and long term performance objectives appropriate to the working of the Company and its goals.

Part - B

Policy for appointment and removal of Director, KMP and Senior Management

Appointment criteria and qualifications

- 1. The Committee shall identify and ascertain the integrity, qualification, expertise and experience of the person for appointment as Director, KMP or senior management level and recommend to the Board his/her appointment.
- 2. A person to be appointed as Director, KMP or senior management level should possess adequate qualification, expertise and experience for the position, he/she is considered for appointment. The Committee has discretion to decide whether qualification, expertise and experience possessed by a person is sufficient/satisfactory for the concerned position.
- 3. A person, to be appointed as Director, should possess impeccable reputation for integrity, deep expertise and insights in sectors/ areas relevant to the Company, ability to contribute to the Company's growth, complimentary skills in relation to the other Board members.
- 4. The Company shall not appoint or continue the employment of any person as Managing Director/Executive Director, who has attained the age of seventy years.
- 5. A Whole-time KMP of the Company shall not hold office in more than one Company, except at its subsidiary Company at the same time. However, a Whole-time KMP can be appointed as a Director in any Company, with the permission of the Board of Directors of the Company.

Term/Tenure

1. Managing Director/Whole-time Director

The Company shall appoint or re-appoint any person, as its Managing Director and CEO or Whole-time Director for a term not exceeding five years at a time. No re-appointment shall be made earlier than one year before the expiry of term.

2. Independent Director

An Independent Director shall hold office for a term up to five consecutive years on the Board of the Company and will be eligible for re-appointment, on passing of a special resolution by the Company and disclosure of such appointment in the Board's Report.

No Independent Director shall hold office for more than two consecutive terms, but such Independent Director shall be eligible for appointment, after expiry of three years of ceasing to become an Independent Director. Provided that an Independent Director shall not, during the said period of three years, be appointed in or be associated with the Company, in any other capacity, either directly or indirectly. However, if a person, who has already served as an Independent Director for five years or more in the Company, as on April 1, 2015 or such other date, as may be determined by the Committee, as per regulatory requirement, he/she shall be eligible for appointment for one more term of five years only.

At the time of appointment of Independent Director, it should be ensured that number of Boards, on which such Independent Director serves, is restricted to seven listed companies, as an Independent Director and three listed companies, as an Independent Director, in case, such person is serving as a Whole-time (Executive) Director of a listed company.

Removal

Due to reasons for any disqualification mentioned in the Companies Act, 2013, rules made there under or under any other applicable Act, rules and regulations, the Committee may recommend, to the Board with reasons recorded in writing, removal of a Director or KMP subject to the provisions and compliance of the said Act, rules and regulations.

Retirement

The whole-time Directors, KMP and senior management personnel shall retire as per the applicable provisions of the Companies Act, 2013 and the prevailing policy of the Company. The Board will have the discretion, to retain the Whole-time Directors, KMP and senior management personnel, in the same position/remuneration or otherwise, even after attaining the retirement age, for the benefit of the Company.

PART - C

Policy relating to the remuneration for Directors, KMP and other employees.

General

- 1. The remuneration/compensation/commission etc. to Directors will be determined by the Committee and recommended to the Board for approval.
- 2. The remuneration and commission to be paid to the Chairman & Managing Director and Vice Chairman & Managing Director, shall be in accordance with the provisions of the Companies Act, 2013, and the rules made thereunder.
- 3. Increments to the existing remuneration/compensation structure, may be recommended by the Committee to the Board, which should be within the limits approved by the Shareholders, in the case of Managing Director.
- 4. Where any insurance is taken by the Company, on behalf of its Managing Director, Chief Financial Officer, Company Secretary and any other employees, for indemnifying them against any liability, the premium paid on such insurance shall not be treated as part of the remuneration payable to any such personnel, provided that if such person is proved to be guilty, the premium paid on such insurance shall be treated as part of the remuneration.

Remuneration to KMP and other employees

The policy on remuneration for KMP (other than Chairman & Managing Director and Vice Chairman & Managing Director) and other employees, will be governed as per the HR Policy of the Company and increment will be paid accordingly.

Remuneration to Non-Executive / Independent Directors

1. Remuneration

The remuneration payable to each Non-Executive Director is based on the remuneration structure, as determined by the Board and revised from time to time, depending on individual contribution, the Company's performance and the provisions of the Companies Act, 2013 and the rules made thereunder.

The remuneration to the Non-executive Directors (including Independent Directors), may be paid within the monetary limit approved by shareholders, subject to the limit not exceeding 1.5% of the profits of the Company, computed as per the applicable provisions of the Companies Act, 2013.

2. Stock options

The Independent Directors shall not be entitled to any stock option of the Company.

Policy Review

This policy is framed based on the provisions of the Companies Act, 2013 and rules thereunder and the requirements of the Clause 49 of the Equity Listing Agreement with the Stock Exchanges.

In case of any subsequent changes in the provisions of the Companies Act, 2013 or any other regulations, which makes any of the provisions in the policy, in consistent with the Act or regulations, then the provisions of the Act or regulations would prevail over the policy and the provisions in the policy, would be modified in due course to make it consistent with law.

This policy shall be reviewed by the Nomination & Remuneration Committee, as and when, any changes are to be incorporated in the policy, due to change in regulations or as maybe felt appropriate by the Committee. Any changes or modification on the policy as recommended by the Committee would be given for approval of the Board of Directors.

IB. Board Evaluation Policy

1. Introduction

- 1.1 The challenge for Board is to prevent crisis in the organisation they govern. Performance evaluation is a key means by which Board can recognise and correct corporate governance problems and add real value to their organisations.
- 1.2 Board and Director's evaluation involves Board members undertaking a constructive but critical review of their own performance, identifying strengths, weaknesses and implementing plans for further professional development. The provision of feedback on Board performance and governance processes, is the most crucial element of Director's evaluation.
- 1.3 To enable Directors of the Company to evaluate their individual performance, as well as the collective performance of the Board, the Board has developed a framework for evaluating Board's effectiveness. This Policy is in compliance with Section 178 of the Companies Act, 2013, read with the applicable rules thereto and Clause 49 under the Listing Agreement.

2. Purpose

- 2.1 The primary objective of the Policy is, to provide a framework and set standards for the evaluation of the Board as a whole, its Committees and Directors. The Company aims to achieve a balance of merit, experience and skills on the Board.
- 2.2 The Board's policy is to assess the effectiveness of the Board as a whole and its Board Committees. Individual Board members are assessed on their effective contribution and commitment to their role and responsibilities as directors. The Board evaluation process shall be carried out by the Nomination and Remuneration Committee of the Board of Directors ("The NR Committee").

3. Objectives of evaluation

3.1 The objective to undertake evaluation of Board and Individual Directors are as under:

- (a) To demonstrate commitment to performance management;
- (b) To review problems in the dynamics of the Board room or between the Board and Management;
- (c) To enhance good corporate governance;
- (d) To provide Directors with guidance for their learning and growth and
- (e) To develop appropriate skills, competencies and motivation on the Board.

4. Scope of Evaluation

4.1 Evaluation of the Board as a whole

Regular evaluation of the Board as a whole can be seen as a process, that ensures Directors develop a shared understanding of their governance, role and responsibilities. It serves as an excellent familiarisation tool for Board.

4.2 Individual Directors' Evaluation

Individual evaluation provides the Board with an opportunity to probe particular issues in depth.

5. Method of Evaluation

- 5.1 Depending on the degree of formality, the objectives of the evaluation and there sources available, the evaluation process will involve a range of qualitative and quantitative techniques.
- 5.2 To evaluate Individual Directors, either self or peer evaluation techniques is to be used. The aim of self-evaluation is to encourage Directors, to reflect on their contributions to Board activities and have them identify their personal

strengths and weaknesses. An objective view is best gained through peer evaluation, whereby Directors identify each other's individual strengths and weaknesses. By having members of the Board evaluate each other, it is possible to gain a more rounded picture of the strengths and weaknesses of each director and their contribution to the effectiveness of the Board. It can also be used to identify skill gaps on the Board.

6. Process for Evaluation of the Board as a whole and its Board Committees

- 6.1 Each of the Directors will complete all sections of the Board Self Evaluation Form honestly and sincerely. The Directors will also be required to provide comments, to explain the ratings allocated. A rating scale of "1" to "5" is employed, wherein "1" denotes a strong rating and "5" a critical condition.
- 6.2 The above Forms will be submitted by the Directors to the NR Committee on an annual basis, within 30 days of the end of every financial year.
- 6.3 Based on the Forms submitted, the NR Committee shall assess and discuss the performance of the Board as a whole and its Committees every year and ascertain key areas for improvement and the requisite follow-up actions.

7. Process for Evaluation of Individual Directors

- 7.1 The evaluation/assessment of the Directors of the Company is to be conducted on an annual basis and to satisfy the requirements of the Listing Agreement.
- 7.2 The Non-Executive Directors ("NEDs"), led by the NR Committee's Chairman, shall assess the performance of the Chairman and other Directors. The Chairman shall meet with each Individual Director, to discuss the evaluation and any matter relating to the functioning of the Board.
- 7.3 Each Non-Executive Director's ("NED") contribution will be assessed by the Chairman and the results of the assessment will be discussed with the NR Committee Chairman.
- 7.4 Criteria for assessment of NEDs include attendance record, intensity of participation at meetings, quality of intervention and special contributions.
- 7.5 Each of the Directors (other than director being evaluated) will complete all sections of Individual Director Assessment Form and Non-Executive Director Assessment Form, honestly and sincerely. The Directors will also be required to provide comments, to explain the ratings allocated. A rating scale of "1" to "5" is employed, wherein "1" denotes strong rating and "5" a critical condition.
- 7.6 The following criteria may assist in determining, how effective the performances of the Directors have been:
 - leadership & stewardship abilities
 - contributing to clearly define corporate objectives & plans
 - communication of expectations & concerns, clearly with subordinates
 - obtain adequate, relevant & timely information from external sources.
 - review & approval achievement of strategic and operational plans, objectives, budgets
 - regular monitoring of corporate results against projections
 - identify, monitor & mitigate significant corporate risks
 - assess policies, structures & procedures
 - review management's succession plan
 - effective meetings

- assuring appropriate Board size, composition, independence, structure
- clearly defining roles & monitoring activities of Committees
- review of corporation's ethical conduct
- 7.7 Evaluation on the aforesaid parameters will be conducted by the Independent Directors for each of the Executive/ Non-Independent Directors in a separate meeting of the Independent Directors.
- 7.8 The Executive Director/Non-Independent Directors along with the Independent Directors, will evaluate/assess each of the Independent Directors on the aforesaid parameters. Only the Independent Director being evaluated will not participate in the said evaluation discussion.

8. Reporting to Board

At the end of the evaluation process, the Chairman of NR Committee shall submit a report to the Board members on the results of the evaluation process.

Based on my verification of the Hindusthan National Glass & Industries Limited's books, papers, minute books, forms and returns filed and other records maintained by the Company and also the information provided by the Company, its officers, agents and authorized representatives during the conduct of secretarial audit, I hereby report that in my opinion, the Company has, during the audit period covering the financial year ended on 31st March, 2022 generally complied with the statutory provisions listed hereunder and also that the Company has proper Board processes and compliance mechanism in place to the extent, in the manner and subject to the reporting made hereinafter:

I have examined the books, papers, minute books, forms and returns filed and other records maintained by Hindusthan National Glass & Industries Limited ("the company") for the financial year ended on 31st March, 2022 according to the provisions of:

- i) I have examined compliance with the applicable clauses of the Secretarial Standards on the Meetings of the Board of Directors, Committees and General Meetings issued by The Institute of Company Secretaries of India, with which the Company has complied with.
- ii) The Listing Agreements entered into by the Company NSE, BSE and CSE.
- iii) Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

During the period under review the Company has complied with the provisions of the Act, Rules, Regulations, Guidelines, Standards, etc. mentioned above.

I further report that

The Board of Directors of the Company is duly constituted with proper balance of Executive Directors, Non-Executive Directors, a Woman Director and Independent Directors. There were no Changes in the composition of the Board of Directors except that Mr. Dipankar Chatterjee an Independent Director of the Company has resigned w.e.f. 26th July, 2021. As per SEBI (LODR) Regulation 17(1)(c) the company is required to have minimum six Directors on its Board. However, the Company has only five Directors since 26th July, 2021. However, as the Company is under Corporate Insolvency Resolution Process, this clause is not applicable w.e.f. 21.10.2021

Adequate notice is given to all directors and Interim Resolution Professional to schedule the Board Meetings, agenda and detailed notes on agenda were sent at least seven days in advance, and a system exists for seeking and obtaining further information and clarifications on the agenda items before the meeting and for meaningful participation at the meeting. During the year the meetings of the Board of Directors and Committees thereof have been held through VCM in accordance with various Circulars issued by SEBI and MCA in view of pandemic situation.

Majority decision is carried through while the dissenting members' views, if any, are captured and recorded as part of the minutes.

I further report that the Hon'ble National Company Law Tribunal (NCLT) - Kolkata Bench has admitted, the application for initiation of Corporate Insolvency Resolution Process ('CIRP') under Section 7 of the Insolvency and Bankruptcy Code, 2016 ('IBC') which was filed by DBS Bank Limited, in its capacity as a Financial Creditor of the company before the NCLT, vide its Order dated 21st October, 2021. Accordingly, Mr. Girish Siriram Juneja, having registration No. IBBI/IPA-001/IP-P00999/2017-18/11646 has been appointed as Resolution Professional (RP) and the Committee of Creditors (CoC) has been formed. The RP has published the advertisement seeking Expression of Interest (EoI) from the prospective Resolution Applicants under the CIRP. The process of verification of claims is under progress.

Further an appeal has been filed by one of the Promoter of the Company with Hon'ble National Company Law Appellate Tribunal (NCLAT), New Delhi against the aforesaid order of Hon'ble NCLT. The appeal was scheduled to be heard on 1st April, 2022. However, it could not be heard as the concerned Court was not in session on that day. The next date of the hearing is fixed on 14th July, 2022.

I further report that during the year upto September, 2022, State Bank of India, the lead banker, has appropriated a sum of Rs. 3502 lakhs out of promoter contribution, internal accruals and the cut back for repayment to the lendors of the consortium, which the company has adjusted from the Principal obligation of the debt.

I further report that post initiation of CIRP all the meeting of the Board of Directors and Committees are being chaired by the Resolution Professional.

I further report that as on date the status of the Company on MCA Portal is "UNDER CORPORATE INSOLVENCY RESOLUTION PROCESS"

I further report that during the Audit period there were no other specific events/actions having a major bearing on the Company's affairs in pursuance of the above-referred laws, rules, regulations, guidelines, and standards etc., referred to above.

Corporate Governance Report

In accordance with an application made by DBS Bank, Financial Creditor of the Company, the Hon'ble National Company Law Tribunal, Kolkata Bench, vide its order dated 21st October, 2021 ("Order") has initiated Corporate Insolvency Resolution Process ("CIRP") against your Company under Section 7 of the Insolvency and Bankruptcy Code, 2016 ("the Code"). Pursuant to the Order, the powers of the Board of Directors stand suspended and are vested with Mr. Girish Siriram Juneja (IP Registration No. IBBI/IPA-001/IP-P00999/2017-2018/11646), who has been appointed as Interim Resolution Professional (IRP) by the Hon'ble NCLT and later confirmed as a Resolution Professional (RP) by the Committee of Creditors (CoC). Further, in consonance with the stipulation contained in Section 17 of the Code, the powers of the Board of Directors of the Company stand suspended effective from CIRP commencement date and the same are vested and exercised by Mr. Girish Siriram Juneja, Resolution Professional.

1. Company's philosophy on Code of Governance

Corporate Governance encompasses a set of systems and practices to ensure that the Company's affairs are being managed in a manner, which ensures accountability, transparency and fairness in all transactions, in the wide sense. HNG believes that transparent and ethical practices, in line with accepted norms of Corporate Governance are essential for long-term success. The Company lays strong emphasis on management accountability, established control systems and individual integrity at all levels. It seeks to ensure that business objectives are balanced with corporate responsibility, to create sustainable value for all stakeholders including shareholders, employees, customers, government and the lenders. 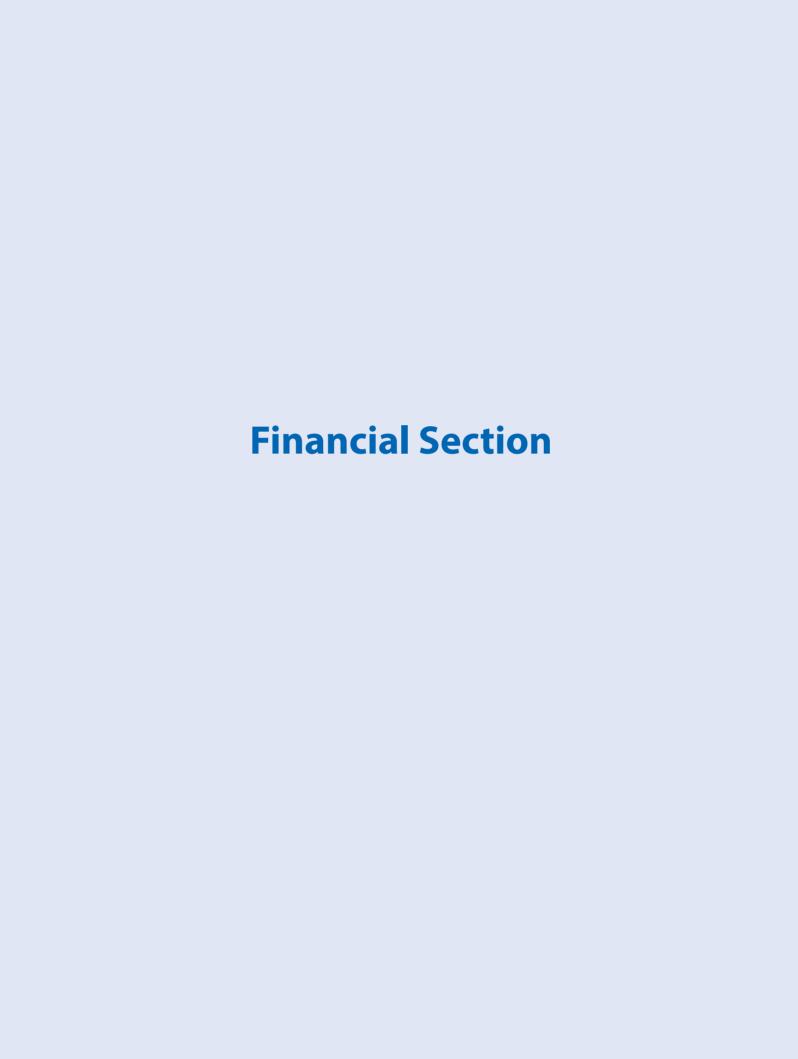

Report on the Audit of the Financial Statements

Qualified Opinion

We have audited the accompanying financial statements of Hindusthan National Glass & Industries Limited ("the Company"), which comprise the balance sheet as at March 31, 2022, the statement of profit and loss (including the statement of other comprehensive income), the statement of changes in equity and the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, except for the effects of the matter described in the Basis for Qualified Opinion section of our report, the aforesaid financial statements give the information required by the Companies Act, 2013 as amended ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015, as amended, ("Ind AS") and other accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2022 and its loss (including other comprehensive income), changes in equity and its cash flows for the year ended on that date.

Basis for Qualified Opinion

- Refer Note no. 2.13.5 (D) of the financial statements, regarding appropriation of payments made by the company during March, 2019 to September, 2021 by the Lead Banker against outstanding loans and adjustment by the management and interest calculations thereon. In absence of any balance confirmation from the lenders and consequent reconciliation with the outstanding balances and impact thereof if any, on the reported figures cannot be ascertained. Also, Refer Note No. 2.45 of the financial statements regarding the pending reconciliations of admitted claims of financial creditors, operational creditors and others with the books of accounts, impact if that may arise has not been considered in the preparation of the financial results for the year ended 31st March, 2022.
- As stated in the Note no. 2.21.1 of the financial statements regarding the non-accounting of interest of Rs.8,775 lakhs as calculated by the company on outstanding borrowings (including Non-Convertible Debentures) post initiation of Corporate Insolvency Resolution Process ('CIRP') with effect from October 21, 2021 under Section 14 of Insolvency and Bankruptcy Code, 2016 ('IBC').
- As stated in the Note no. 2.13.7 of the financial statements, the company has restated the ECB borrowings of USD 641.27 lakhs at foreign currency exchange rate of Rs.74.7635 per USD as on October 21, 2021 (date of initiation of CIRP) as against exchange rate of Rs.75.8071 per USD as on March 31, 2022 resulting in short booking of exchange loss of Rs.669 lakhs in the books of accounts which has consequent impact on the result for the quarter and year ended March 31, 2022.
- Refer Note no. 2.38 of the financial statements which indicates that the company has accumulated losses and its net worth has completely eroded, the company has incurred net loss during the current year and in the earlier year(s), the company's current liabilities exceeds its current assets and the company is having a high debt-equity ratio (debt being Rs.2,26,319 lakhs and equity being Rs.(76,636) lakhs) as at March 31, 2022 realizable value of assets is lower than the amount payable to secured creditors, earnings per share is negative. In our opinion, based on the above, the company does not appear to be a going concern.
- The members of the lenders consortium set aside Rs.1,238 lakhs in FY 2019-20 towards corpus fund for meeting legal expenses, out of which, claim amounting to Rs.131 lakhs have been accounted for based on the details submitted by the bank during the current financial year, however no proper documents from the bank is available for the same. The remaining amount of Rs.1,107 lakhs are lying unadjusted in the books of accounts as on 31.03.2022 which is subject to confirmation from the bank.

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Act. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the company in accordance with the Code of Ethics

issued by the Institute of Chartered Accountants of India (ICAI) together with the ethical requirements that are relevant to our audit of financial statements under the provisions of the Act and Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

Emphasis of Matter

We draw attention to Note no. 1.1.b of the financial statements, the Hon'ble National Company Law Tribunal (NCLT), Kolkata Bench, vide its order dated October 21, 2021 has admitted the Company for initiation of Corporate Insolvency Resolution Process (CIRP) under the Insolvency and Bankruptcy code, 2016 (IBC). Our opinion is not modified in respect of this matter.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matter described in the Basis for Qualified Opinion section we have determined the matters described below to be the key audit matters to be communicated in our report.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a quarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

 - The matter described in the Basis for Qualified Opinion paragraph above, in our opinion, may have an adverse effect on the functioning of the Company.
 - (f) On the basis of the written representations received from the directors and taken on record by the Board of Directors, none of the directors are disqualified as on March 31, 2022, from being appointed as a director in terms of section 164(2) of the Act. However, considering the fact, that the Company has defaulted in payment of interest on Non-Convertible Debentures from the dates mentioned in Note No. 2.13.6(c) of the financial statements, in our opinion, all the directors are disqualified from being appointed as director in terms of Section 164 (2) of the Act.
 - (g) The qualification relating to the maintenance of accounts and other matters connected therewith is as stated in the Basis for Qualified Opinion paragraph above.
 - With respect to the adequacy of the internal financial controls over financial reporting of the Company (h) and the operating effectiveness of such controls, refer to our separate Report in "Annexure B".
 - With respect to the other matters to be included in the Auditor's Report in accordance with the requirements of section 197(16) of the Act, as amended:
 - In our opinion, and to the best of our information and according to the explanations given to us, the company has not paid any managerial remuneration during the financial year other than the sitting fees to its independent directors which is in accordance with the provisions of section 197(5) read with Rule 4 of Companies (Appointment & Remuneration of the Managerial Personnel) Rule, 2014 (as amended) of the Act.
 - With respect to the other matters to be included in the Auditors' Report in accordance with Rule 11 of the



Companies (Audit and Auditors) Rules, 2014 (as amended), in our opinion and to the best of our information and according to the explanations given to us:

- i. The Company has disclosed (other than those already recognized in the accounts) the impact of pending litigations on its financial position in its financial statements Refer Note No. 2.32.A of the financial statements.
- ii. The Company did not have any long-term contracts including derivative contracts for which there were any material foreseeable losses.

1: Summary of Significant Accounting Policies

1.1. **Corporate Information**

- Hindusthan National Glass & Industries Limited having domicile presence in the State of West Bengal, India, has been incorporated under the Companies Act in the year 1946. It is engaged in the manufacturing of container glass. The company's shares are listed and publicly traded on the National Stock Exchange Limited (NSE), The Bombay Stock Exchange Limited (BSE) and The Calcutta Stock Exchange Limited (CSE).
- The Hon'ble National Company Law Tribunal (NCLT), Kolkata Bench, vide its order dated October 21, 2021 has b. admitted the Company for initiation of Corporate Insolvency Resolution Process (CIRP) under the Insolvency and Bankruptcy code, 2016 (IBC) and appointed Mr Girish Siriram Juneja having Registration no IBBI/IPA-001/ IP-P00999/2017-18/11646 as the Interim Resolution Professional. In a appeal filed by the promoters with NCLAT opposing the admission of the Company to Insolvency the Hon'ble NCLAT New Delhi stayed the Constitution of the COC by its order dt October 28, 2021. Further NCLAT vide its order dated January 18, 2022. vacated the stay on the formation of COC. Thereafter at the 1st Meeting of the Committee of Creditors of the Company held on January 28, 2022 the evoting results of which concluded on Feb 9, 2022, the Interim Resolution Professional Mr Girish Siriram Juneja has been appointed as the Resolution Professional and he is to be supported in the CIRP by EY Restructuring LLP as the Insolvency Professional Entity. Powers of the Board of Directors of the Company stand suspended and such powers are exercised by RP. The next date of hearing of appeal filed by the promoters in NCLAT is schedule on July 14, 2022. As per the current CIRP timelines, the 180 days of the CIRP period (excluding 82 days of stay period) expires on 10th July 2022. The RP has filed an application for extension with the Honorable National Company Law Tribunal, Kolkata Bench seeking an extension of a period of 90 days under Section 12(2) of the Code and the matter is currently pending for hearing.
- The financial statements of the Company have been prepared by the management of the Company, reviewed by the audit committee and approved in the meeting of Director's chaired by RP held on May 24, 2022 and certified by the Director and Chief Financial Officer of the Company. The RP has relied upon the assistance provided by the members of the Audit Committee in review of the Financial Statements and certifications, representations and statements made by Director of the Company in relation to these Financial Statements. As authorized, Director and Chief Financial Officer of the Company have signed the Financial Statements and the RP has taken on record the said statement of Financial Statements only to the limited extent of discharging the powers of the Board of Directors of the Company which has been conferred upon him in terms of provisions of Section 17 of the IBC.

Basis of Preparation

1.2.1. Statement of Compliance

These financial statements have been prepared in accordance with the Indian Accounting Standards (Ind AS) as per the Companies (Indian Accounting Standards) Rules, 2015 (as amended) notified under Section 133 of Companies Act, 2013 (the Act) and other relevant provisions of the Act.

1.2.2. Functional and Presentation Currency

These financial statements are presented in Indian Rupees (INR), which is also the Company's functional currency. All amounts have been rounded off to the nearest two decimals of lakhs, unless otherwise indicated.

1.2.3. Historical Cost Convention

The financial statements have been prepared following accrual basis of accounting on a historical cost basis, except for the following which are measured at fair value:

- a. Certain financial assets and liabilities
- b. Defined Benefit Plans

1.2.4. Fair Value Measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date under current market conditions.

The Company categorizes assets and liabilities measured at fair value into one of three levels depending on the ability to observe inputs employed for such measurement:

- a) Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities.
- b) Level 2: inputs other than quoted prices included within level 1 that are observable either directly or indirectly for the asset or liability.
- c) Level 3: inputs for the asset or liability which are not based on observable market data.

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorisation, based on the lowest level input that is significant to the fair value measurement, at the end of each reporting period.

The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs. External valuers are involved for valuation of significant assets and liabilities. Involvement of external valuers is decided upon annually by the Management. Selection criteria include market knowledge, reputation, independence and whether professional standards are maintained. The Management decides, after discussions with the Company's external valuers, which valuation techniques and inputs to use for each case.

At each reporting date, the Management analyses the movements in the values of assets and liabilities which are required to be re-measured or re-assessed as per the Company's accounting policies.

For the purpose of fair value disclosures, the Company has determined classes of assets and liabilities on the basis of the nature, characteristics and risks of the asset or liability and the level of the fair value hierarchy as explained above.

1.2.5. Current Vs Non-current Classification

The Company presents assets and liabilities in the balance sheet based on current/ non-current classification. An asset is classified as current when it is:

- > Expected to be realized or intended to sold or consumed in normal operating cycle;
- > Held primarily for the purpose of trading;
- > Expected to be realized within twelve months after the reporting period; or
- > Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All the other assets are classified as non-current.

A liability is current when:

- > It is expected to be settled in normal operating cycle;
- > It is held primarily for the purpose of trading;
- It is due to be settled within twelve months after the reporting period; or
- > There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

The Company classifies all other liabilities as non-current. Deferred Tax Assets and Liabilities are classified as noncurrent assets and liabilities respectively.

1.2.6. Use of Estimates and Judgements

In preparing these financial statements, management has made judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses and the accompanying disclosures including contingent liabilities. Actual results may differ from these estimates. Difference between actual results and estimates are recognised in the period prospectively in which the results are known/ materialised.

Estimates and underlying assumptions are reviewed on an ongoing basis and are based on historical experience and other factors, including expectation of future events that may have a financial impact on the Company and that are believed to be reasonable under the circumstances. Detailed information about estimates and judgements is included in Note 1.4.

Significant Accounting Policies 1.3.

1.3.1. Property Plant and Equipment

Property, plant and equipment (PPE) are stated at cost of acquisition or deemed cost on the date of transition less accumulated depreciation and impairment losses, if any. Cost of an asset comprises of cost of acquisition or construction and includes, where applicable, inward freight, duties and taxes, installation expenses, professional fees, borrowing costs, initial estimates of the cost of dismantling, cost of replacing parts of the property, plant and equipments and other costs directly attributable to the bringing the asset to the location and condition necessary for it to be capable of operating in the intended manner and purposes. Capital Spare parts which are integral part of the plant and equipment are capitalised. When significant parts of plant and equipment are required to be replaced at intervals, the same are capitalised and old component is derecognised.

Capital work in progress includes machinery to be installed, construction and erection materials, borrowing costs, unallocated pre-operative and other expenditures directly attributable towards construction and erection of the assets.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment.

Assets to be disposed off are reported at the lower of the carrying value or the fair value less cost to sell.

Depreciation on PPE commences when the assets are ready for their intended use.

- Depreciation has been provided (a) as per the useful life specified under Schedule II to the Companies Act, 2013 on assets installed/acquired up to March 31, 1990 on written down value method and in respect of additions thereafter on straight line method; (b) in case of certain items of Plants and Equipments where useful life ranging from 5 to 30 years has been considered based on technical assessment, which is different from the useful life prescribed under Schedule II of the Companies Act, 2013.
- Certain Plant and Equipments have been considered as continuous process plant as defined under Schedule Il to the Companies Act, 2013 on the basis of technical evaluation.
- Subsequent costs are depreciated over the remaining life of the plant and equipment.
- Depreciation on incremental cost of arising on account of exchange difference is amortised on straight line method over the remaining life of the asset.

Based on above, the estimated useful lives of assets for the current period are as follows:

Depreciation methods, useful lives and residual values are reviewed, and adjusted as appropriate, at each reporting date.

1.3.2. Intangible Assets

Intangible assets are stated at cost comprising of purchase price inclusive of duties and taxes, where applicable, less accumulated amount of amortization and impairment losses. Such assets, are amortized over the useful life using straight line method and assessed for impairment whenever there is an indication of the same.

Accordingly, cost of computer software packages has been allocated / amortized over a period of 3 to 5 years on straight line basis.

1.3.3. Derecognition of Tangible and Intangible Assets

An item of PPE is de-recognised upon disposal or when no future economic benefits are expected to arise from its use or disposal. Gain or loss arising on the disposal or retirement of an item of PPE is determined as the difference between the sale proceeds and the carrying amount of the asset and is recognized in the Statement of Profit and Loss.

1.3.4. Leases

The Company evaluates if an arrangement qualifies to be a lease as per the requirements of Ind AS 116. Identification of lease requires significant judgement. The company uses significant judgement in assessing the lease term (including anticipated renewals) and the applicable discount rate.

The company determines the lease term as non-cancellable period of a lease, together with both the periods covered by an option to extend the lease if the company is reasonably certain to exercise that option; and periods covered by an option to terminate the lease if the company is certain not to exercise that option. In assessing whether the company is reasonably certain to exercise an option to terminate a lease, it considers all relevant facts and circumstances that create an economic incentive for the Company to exercise the option to extend the lease, or not to exercise the option to terminate the lease. The company revises the lease term if there is a change in the non-cancellable period of a lease.

1.3.5. Impairment of Tangible and Intangible Assets

Tangible and Intangible assets are reviewed at each balance sheet date for impairment. In case events and circumstances indicate any impairment, recoverable amount of assets is determined. An impairment loss is recognized in the statement of profit and loss, whenever the carrying amount of assets either belonging to Cash Generating Unit (CGU) or otherwise exceeds recoverable amount. The recoverable amount is the higher of assets fair value less cost of disposal and its value in use.

In assessing value in use, the estimated future cash flows from the use of the assets are discounted to their present value at appropriate rate.

Impairment losses recognized earlier may no longer exist or may have come down. Based on such assessment at each reporting period the impairment loss is reversed and recognized in the Statement of Profit and Loss. In such cases the carrying amount of the asset is increased to the lower of its recoverable amount and the carrying amount that have been determined, net of depreciation, had no impairment loss been recognized for the asset in prior years.

1.3.6. Financial Assets and Liabilities

Financial assets and financial liabilities (financial instruments) are recognized when Company becomes a party to the contractual provisions of the instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognized immediately in the Statement of Profit and Loss.

The financial assets and financial liabilities are classified as current if they are expected to be realised or settled within operating cycle of the company or otherwise these are classified as non-current.

The classification of financial instruments whether to be measured at Amortized Cost, at Fair Value through Profit and Loss (FVTPL) or at Fair Value through Other Comprehensive Income (FVTOCI) depends on the objective and contractual terms to which they relate. Classification of financial instruments are determined on initial recognition.

> Cash and cash equivalents

All highly liquid financial instruments, which are readily convertible into determinable amounts of cash and which are subject to an insignificant risk of change in value and are having original maturities of three months or less from the date of purchase, are considered as cash equivalents. Cash and cash equivalents includes balances with banks which are unrestricted for withdrawal and usage.

> Financial Assets and Financial Liabilities measured at amortized cost

Financial Assets held within a business whose objective is to hold these assets in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding are measured at amortized cost.

The above Financial Assets and Financial Liabilities subsequent to initial recognition are measured at amortized cost using Effective Interest Rate (EIR) method.

The effective interest rate is the rate that exactly discounts estimated future cash payments or receipts (including all fees and points paid or received, transaction costs and other premiums or discounts) through the expected life of the Financial Asset or Financial Liability to the gross carrying amount of the financial asset or to the amortised cost of financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

> Financial Asset at Fair Value through Other Comprehensive Income (FVTOCI)

Financial assets are measured at fair value through other comprehensive income if these financial assets are held within a business whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. Subsequent to initial recognition, they are measured at fair value and changes therein are recognized directly in other comprehensive income.

> For the purpose of para (ii) and (iii) above, principal is the fair value of the financial asset at initial recognition and interest consists of consideration for the time value of money and associated credit risk.

Financial Assets or Liabilities at Fair value through profit or loss

Financial Instruments which do not meet the criteria of amortized cost or fair value through other comprehensive income are classified as Fair Value through Profit or loss. These are recognised at fair value and changes therein are recognized in the statement of profit and loss.

Derivatives and Hedge Accounting

The company enters into derivative financial instruments such as foreign exchange forward and option contracts to mitigate the risk of changes in foreign exchange rates in respect of financial instruments and forecasted cash flows denominated in certain foreign currencies. The Company uses hedging instruments that are governed by the policies of the Company which are approved by the Board of Directors and provide principles on the use of such financial derivatives consistent with the risk management strategy of the Company. The hedge instruments are designated and documented as hedges and effectiveness of hedge instruments to reduce the risk associated with the exposure being hedged is assessed and measured at inception and on an ongoing basis.

Any derivative that is either not designated as a hedge, or is so designated but is ineffective per Ind AS 109 "Financial Instruments", is categorized as a financial asset, at fair value through profit or loss. Transaction costs attributable to the same are also recognized in statement of profit and loss.

Changes in the fair value of the derivative hedging instrument designated as a fair value hedge are recognized in the statement of profit and loss.

Changes in the fair value of the derivative hedging instrument designated as a cash flow hedge are recognized in other comprehensive income and presented within equity as cash flow hedging reserve to the extent that the hedge is effective.

If the hedging instrument no longer meets the criteria for hedge accounting, expires or is sold, terminated or exercised, then hedge accounting is discontinued prospectively. Any gain or loss recognised in other comprehensive income and accumulated in equity till that time remains and thereafter to the extent hedge accounting being discontinued is recognised in Statement of Profit & Loss. When a forecasted transaction is no longer expected to occur, the cumulative gain or loss accumulated in equity is transferred to the statement of profit and loss.

> Impairment of financial assets

A financial asset is assessed for impairment at each reporting date. A financial asset is considered to be impaired if objective evidence indicates that one or more events have had a negative effect on the estimated future cash flows of that asset.

The company measures the loss allowance for a financial assets at an amount equal to the lifetime expected credit losses if the credit risk on that financial instrument has increased significantly since initial recognition. If the credit risk on a financial instrument has not increased significantly since initial recognition, the company measures the loss allowance for that financial instrument at an amount equal to 12-month expected credit losses.

However, for trade receivables or contract assets that result in relation to revenue from contracts with customers, the company measures the loss allowance at an amount equal to lifetime expected credit losses.

> De-recognition of financial instruments

The Company derecognizes a financial asset or a group of financial assets when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another party.

On derecognition of a financial asset (except for equity instruments designated as FVTOCI), the difference between the asset's carrying amount and the sum of the consideration received and receivable are recognized in statement of profit and loss.

On derecognition of assets measured at FVTOCI the cumulative gain or loss previously recognised in other comprehensive income is reclassified from equity to profit or loss as a reclassification adjustment.

Financial liabilities are derecognized if the Company's obligations specified in the contract expire or are discharged or cancelled. The difference between the carrying amount of the financial liability derecognized and the consideration paid and payable is recognized in Statement of Profit and Loss.

1.3.7. Inventories

- > Inventories are valued at lower of the cost or estimated net realizable value. Cost of inventories is ascertained on 'weighted average' basis. Materials and other supplies held for use in the production of inventories are not written down below cost if the finished products in which they will be incorporated are expected to be sold at or above cost.
- > Cost in respect of raw materials and stores and spares includes expenses incidental to procurement of the same. Cost in respect of finished goods and those under progress represents prime cost, and includes appropriate portion of overheads and taxes if any.

1.3.8. Foreign Currency Transactions

Transactions in foreign currencies are translated into the functional currency at the exchange rates prevailing on the date of the transactions. Foreign currency monetary assets and liabilities at the year-end are translated at the yearend exchange rates. Non-monetary items which are carried in terms of historical cost denominated in a foreign currency are reported using the exchange rate at the date of transaction. Foreign exchange gain/loss to the extent considered as an adjustment to Interest Cost are considered as part of borrowing cost. The loss or gain thereon and also on the exchange differences on settlement of the foreign currency transactions during the year are recognized as income or expense in the profit and loss account.

The Company has been applying paragraph 46A of AS 11 under Indian GAAP whereby exchange differences arising on translation/ settlement of long-term foreign currency monetary items pertaining to the acquisition of a depreciable asset are adjusted to the cost of the asset and depreciated over the remaining life of the asset. Ind AS 101 gives an option whereby a first time adopter can continue its Indian GAAP policy for the aforesaid accounting for exchange differences arising from translation of long-term foreign currency monetary items. The Company has adopted the aforesaid option under Ind AS 101.

1.3.9. Equity Share Capital

An equity instrument is a contract that evidences residual interest in the assets of the company after deducting all of its liabilities. Par value of the equity shares is recorded as share capital and the amount received in excess of par value is classified as Securities Premium.

Costs directly attributable to the issue of ordinary shares are recognized as a deduction from equity, net of any tax effects.

1.3.10. Provisions, Contingent Liabilities and Contingent Assets

Provisions involving substantial degree of estimation in measurement are recognized when there is a legal or constructive obligation as a result of past events and it is probable that there will be an outflow of resources and a reliable estimate can be made of the amount of obligation. Provisions are not recognized for future operating losses. The amount recognized as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation.

Contingent liabilities is not recognized and are disclosed by way of notes to the financial statements when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or when there is a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the same or a reliable estimate of the amount in this respect cannot be made.

Contingent Assets are disclosed in the financial statements by way of notes to accounts when an inflow of economic benefits is probable.

1.3.11. Employee Benefits

- > Short term Employee benefits are accrued in the year services are rendered by the employees.
- > Provident & Family Pension Fund: In accordance with the provisions of the Employee Provident Funds and Miscellaneous Provisions Act, 1952, eligible employees of the company are entitled to receive benefits with respect to provident fund, a defined contribution plan, in which both the company and employee contribute monthly to Provident Fund Scheme by the Central Government/Trust at a determined rate. The company contributes to the Employees' Pension Scheme, 1995 for certain categories of employees. The Company's contribution is charged off to the Statement of Profit and Loss.
- > Gratuity Employee benefits under defined benefit plans are determined at the close of each year at the present value of the amount payable using actuarial valuation techniques.
 - Contributions under the scheme for defined benefit under the Payment of Gratuity Act, 1972, is determined on the basis of actuarial valuation and are funded to SBI Life Insurance Company Limited and Birla Sun Life Insurance Company Limited and recognized as year's expenditure. Actuarial gain and losses arising from experience adjustments and changes in actuarial assumptions are recognized in other comprehensive income. Remeasurements are not classified to the statement of Profit and Loss in subsequent periods. Other costs recognized in the Statement of Profit or Loss. Bifurcation of liabilities into Current and Non-current are done based on actuarial valuation report.
- > Leave Encashment Benefits: Leave encashment benefits payable to employees while in service, retirement and on death while in service or on termination of employment. With respect to accumulated leaves outstanding at the year-end are accounted for on the basis of actuarial valuation at the balance sheet date. The present value of such obligation is determined by the projected unit credit method as at the balance sheet date through which the obligations are settled. The resultant actuarial gain or loss on change in present value of defined benefit obligation or change in return of the plan assets is recognized as an income or expense in the Statement of Profit and Loss. Bifurcation of liabilities into Current and Non-current are done based on actuarial valuation report.

1.3.12. Revenue

Sale of Goods

The Company derives revenues primarily from sale of manufactured goods. Revenue from contracts with customers is recognized on satisfaction of performance obligation upon transfer of control of promised goods to a customer at an amount that reflects the consideration to which the Company is expected to be entitled to in exchange for those goods.

Revenue towards satisfaction of a performance obligation is measured at the amount of transaction price (net of variable consideration) allocated to that performance obligation. The transaction price of goods sold is net of variable consideration on account of trade discounts, returns, volume rebates offered by the Company as part of the contract. Revenue (net of variable consideration) is recognized only to the extent that it is highly probable that the amount will not be subject to significant reversal when uncertainty relating to its recognition is resolved.

Sale of Products: Revenue from sale of products is recognized when the control on the goods have been transferred to the customer. The performance obligation in case of sale of product is satisfied at a point in time i.e., when the material is shipped to the customer or on delivery to the customer, as may be specified in the contract.

Interest, Dividend and Claims

Dividend income is recognized when the right to receive payment is established. Interest has been accounted using effective interest rate method. Insurance claims/ other claims are accounted as and when admitted / settled.v

Export Benefits

Export benefits arising on account of entitlement for duty free imports are accounted for through import of materials. Such benefits under Merchandise Exports for India Scheme (MEIS) are accounted for on accrual basis. Other export benefits are accounted for on the basis of certainties as to its utilization and related realization.

1.3.13. Borrowing Cost

Borrowing cost comprises of interest and other costs incurred in connection with the borrowing of the funds. All borrowing costs are recognized in the Statement of Profit and Loss using the effective interest method except to the extent attributable to qualifying Property Plant and Equipment (PPE) which are capitalized to the cost of the related assets. A qualifying PPE is an asset that necessarily takes a substantial period of time to get ready for its intended use or sale. Borrowing cost also includes exchange differences to the extent considered as an adjustment to the borrowing costs.

1.3.14. Research and Development

Research and development cost (other than cost of fixed asset acquired) are charged as an expense in the year in which they are incurred.

1.3.15. Government Grants

Government grants are recognized on systematic basis when there is reasonable certainty of realization of the same. Revenue grants including subsidy/rebates are credited to Statement of Profit and Loss Account under "Other Income" or deducted from the related expenses for the period to which these are related.

Grants which are meant for purchase, construction or otherwise acquire non-current assets are recognized as Deferred Income and disclosed under Non-Current Liabilities and transferred to Statement of Profit and Loss on a systematic basis over the useful life of the respective asset. Grants relating to non-depreciable assets are transferred to Statement of Profit and Loss over the periods that bear the cost of meeting the obligations related to such grants.

When the Company receives grants of non-monetary assets, the asset and the grant are recorded at fair value amounts and released to profit or loss over the expected useful life in a pattern of consumption of the benefit of the underlying asset i.e. by equal annual instalments.

When loans or similar assistance are provided by governments or related institutions, with an interest rate below the current applicable market rate, the effect of this favourable interest is regarded as a government grant. The loan or assistance is initially recognised and measured at fair value and the government grant is measured as the difference between the initial carrying value of the loan and the proceeds received. The loan is subsequently measured as per the accounting policy applicable to financial liabilities.

1.3.16. Taxes on Income

Income tax expense representing the sum of current tax expenses and the net charge of the deferred taxes is recognized in the income statement except to the extent that it relates to items recognized directly in equity or other comprehensive income.

Current income tax is provided on the taxable income and recognized at the amount expected to be paid to or recovered from the tax authorities, using the tax rates and tax laws that have been enacted or substantively enacted by the end of the reporting period. Taxable Income differs from 'profit before tax' as reported in the statement of profit and loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible.

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities in the Financial Statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognized for all taxable temporary differences. Deferred tax assets are generally recognized for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilized.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realized, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the deferred tax asset to be utilized.

Deferred tax assets include Minimum Alternative Tax (MAT) paid in accordance with the tax laws in India, which is likely to give future economic benefits in the form of availability of set off against future income tax liability. Accordingly, MAT is recognized as deferred tax asset in the balance sheet when the sasset can be measured reliably and it is probable that the future economic benefit associated with asset will be realized.

1.3.17. Earnings Per Share

Basic earnings per share are computed by dividing the net profit attributable to the equity holders of the company by the weighted average number of equity shares outstanding during the period. Diluted earnings per share is computed by dividing the net profit attributable to the equity holders of the company by the weighted average number of equity shares considered for deriving basic earnings per share and also the weighted average number of equity shares that could have been issued upon conversion of all dilutive potential equity shares.

1.3.18. Non-current assets held for sale

Non-current assets held for sale are measured at the lower of their carrying amount and the fair value less costs to sell. Assets and liabilities classified as held for sale are presented separately in the balance sheet.

The Company classifies non-current assets as held for sale if their carrying amount will be recovered principally through a sale rather than through continuing use. Actions required to complete the sale should indicate that it is unlikely that significant changes to the sale will be made or that the decision to sell will be withdrawn. Management must be committed to the sale expected within one year from the date of classification.

Property, plant and equipment and intangible assets once classified as held for sale are not depreciated or amortised.

1.3.19. Cash dividend and non-cash distribution to equity holders

The Company recognizes a liability to make cash distributions to equity holders of the Company when the distribution is authorised and the distribution is no longer at the discretion of the Company. Distribution is authorised when it is approved by the shareholders. A corresponding amount is recognized directly in equity.

1.4 Significant Judgements And Key Sources Of Estimation In Applying Accounting Policies

Estimates and judgements are continually evaluated. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the Company and that are believed to be reasonable under the circumstances. Information about Significant judgements and Key sources of estimation made in applying accounting policies that have the most significant effects on the amounts recognized in the financial statements is included in the following notes:

• Recognition of Deferred Tax Assets: The extent to which deferred tax assets can be recognized is based on an assessment of the probability of the Company's future taxable income against which the deferred tax assets can be utilized. In addition, significant judgement is required in assessing the impact of any legal or economic limits.

- Useful lives of depreciable/ amortizable assets (tangible and intangible): Management reviews its estimate of the useful lives of depreciable/amortizable assets at each reporting date, based on the expected utility of the assets. Uncertainties in these estimates relate to actual normal wear and tear that may change the utility of plant and equipment.
- Defined Benefit Obligation (DBO): Employee benefit obligations are measured on the basis of actuarial assumptions which include mortality and withdrawal rates as well as assumptions concerning future developments in discount rates, medical cost trends, anticipation of future salary increases and the inflation rate. The Company considers that the assumptions used to measure its obligations are appropriate. However, any changes in these assumptions may have a material impact on the resulting calculations.
- **Provisions and Contingencies:** The assessments undertaken in recognizing provisions and contingencies have been made in accordance with Indian Accounting Standards (Ind AS) 37, 'Provisions, Contingent Liabilities and Contingent Assets'. The evaluation of the likelihood of the contingent events is applied best judgement by management regarding the probability of exposure to potential loss.
- Impairment of Financial Assets: The Company reviews its carrying value of investments carried at amortized cost annually, or more frequently when there is indication of impairment. If recoverable amount is less than its carrying amount, the impairment loss is accounted for.
- Allowances for Doubtful Debts: The Company makes allowances for doubtful debts through appropriate estimations of irrecoverable amount. The identification of doubtful debts requires use of judgment and estimates. Where the expectation is different from the original estimate, such difference will impact the carrying value of the trade and other receivables and doubtful debts expenses in the period in which such estimate has been changed.
- Fair value measurement of financial Instruments: When the fair values of financial assets and financial liabilities recorded in the balance sheet cannot be measured based on quoted prices in active markets, their fair value is measured using valuation techniques including the Discounted Cash Flow model. The input to these models are taken from observable markets where possible, but where this not feasible, a degree of judgement is required in establishing fair values. Judgements include considerations of inputs such as liquidity risk, credit risk and volatility.

1.5 **Recent applicable Accounting pronouncements**

Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time. On March 23, 2022, MCA amended the Companies (Indian Accounting Standards) Amendment Rules, 2022, as below-

- Ind AS 16 Property, Plant and Equipment The amendment clarifies that excess of net sale proceeds of items produced over the cost of testing, if any, shall not be recognised in the profit or loss but deducted from the directly attributable costs considered as part of cost of an item of property, plant and equipment. The effective date for adoption of this amendment is annual periods beginning on or after April 1, 2022.
- Ind AS 37 Provisions, Contingent Liabilities and Contingent Assets The amendment specifies that (ii) the 'cost of fulfilling' a contract comprises the 'costs that relate directly to the contract'. Costs that relate directly to a contract can either be incremental costs of fulfilling that contract (examples would be direct labour, materials) or an allocation of other costs that relate directly to fulfilling contracts (an example would be the allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract). The effective date for adoption of this amendment is annual periods beginning on or after April 1, 2022, although early adoption is permitted.
- (iii) Ind AS 103 – Reference to Conceptual Framework – The amendments specify that to qualify for recognition as part of applying the acquisition method, the identifiable assets acquired and liabilities assumed must meet the definitions of assets and liabilities in the Conceptual Framework for Financial Reporting under Indian Accounting Standards (Conceptual Framework) issued by the Institute of Chartered Accountants of India at the acquisition date. These changes do not significantly change the requirements of Ind AS 103.

- Ind AS 109 Annual Improvements to Ind AS (2021) The amendment clarifies which fees an entity includes when it applies the '10 percent' test of Ind AS 109 in assessing whether to derecognise a financial liability.
- (v) Ind AS 116 - Annual Improvements to Ind AS (2021) - The amendments remove the illustration of the reimbursement of leasehold improvements by the lessor in order to resolve any potential confusion regarding the treatment of lease incentives that might arise because of how lease incentives were described in that illustration.

- 2.13.4 (a) Pursuant to RBI guidelines for Framework for Revitalizing Distressed Assets in the Economy, which laid out the detailed guidelines on formation of Joint Lenders Forum (JLF) and Corrective Action Plan (CAP), if 75% of lenders by value and 60% by number are agreeable to CAP, then it shall become binding on all the lenders. In terms of the CAP approved by JLF, the terms and conditions of the outstanding term loans from Banks and Financial Institutions have been restructured with effect from 1st December, 2014. This inter-alia includes moratorium for repayment of principal for two years and thereafter the aforesaid loans to be repaid over the period of 5 to 8 years depending on the nature of the loan. The said restructuring is, however subject to fulfillment of certain conditions and creation of securities etc. including those given in Note 2.13.4(c) The stipulations also includes conditions relating to infusion of equity by promoters in various periods and fresh valuations of its assets by a valuer registered with Institute of Valuers.
 - (b) All the loans restructured as above, in addition to their existing securities, have been further secured by pledge of remaining unencumbered promoter shareholding (being 51% of the Company's shareholding) and Personal guarantee of Mr. Sanjay Somany and Mr. Mukul Somany.
 - (c) Pursuant to the CAP, lenders shall have a right to convert into Equity upto 20% of the Term Loan outstanding beyond seven years as per SEBI guidelines/ Loan covenants whichever is applicable.
- 2.13.5 The continuous higher financial leverage and lower profitability plagued the financials of the Company. To reduce the leverage, company approached the lenders for compromise settlement pursuant to RBI's circular on Resolution of Stressed Assets Revised Framework dated 12th February, 2018.

Pursuant to the said guidelines, Lenders have agreed for a one time compromise settlement of their dues and entered into a Memorandum of Understanding (MOU) with the Company dated 27 August, 2018 and Compromise and Settlement Agreement dated 25th September, 2018.

The brief summary of the MOU signed by the Company and the lenders are as follows:

- A. The entire dues (Term Loan, Fund based Working Capital, Letter of Credit and interest thereon) as outstanding as on 28 February, 2018 shall be settled by payment of cash component of Rs. 1,71,000 Lakhs.
- B. Pay out of the non-fund based facilities granted to the borrower amounting to Rs. 22,208 Lakhs or actual amount outstanding.
- C. Issue/transfer of 90 lakhs equity shares in favour of secured creditors to be based on total fund based exposure.
- D. The Company has deposited an amount of Rs. 29,000 Lakhs which is 15% of the settlement amount with State Bank of India, as per the terms & conditions of the Memorandum of Understanding (MOU) with the Company dated 27 August ,2018 and Compromise and Settlement Agreement dated 25 September ,2018. Further the company has deposited a sum of Rs. 26,001.57 Lakhs from June'19 to Sept'21 and the same has been appropriated by the lead banker, State Bank of India to all the lenders.

The Company has assessed that the use of the going concern assumption is appropriate in the circumstances and hence, these financial statements have been prepared on a going concern assumption basis as per below:

- a) The Code requires the RP to, among other things, run the Company as a goingconcern during CIRP.
- b) The RP, in consultation with the Committee of Creditors ('CoC') of the Company, in accordance with the provisions of the IBC, is making all endeavors to run the Company as a going concern along with the assistance of the management of the company basis the future business outlook and the continuity in the operations of the company.

Pending the completion of the CIRP process, these financial statements have been prepared on a going concern basis.

2.39 GRATUITY AND OTHER POST-EMPLOYMENT BENEFIT PLANS

The Company has a defined benefit gratuity plan. Every employee who has completed five years or more of service is entitled to Gratuity on terms not less favourable than the provisions of The Payment of Gratuity Act, 1972. The scheme is funded with the insurance companies.

The Company also extends benefit of compensated absences to the employees, whereby they are eligible to carry forward their entitlement of earned leave for encashment upon retirement/separation. This is an unfunded plan.

The Company has a separate Provident Fund Trust (funded) whereby, all the employees are entitled to benefits as per Provident Fund Act / Trust Deed. Any shortfall for the Trust is borne by the Company, hence the same is treated as a defined benefit scheme.

(ii) Fair Value Technique

2.42 Financial Risk Management Objectives and policies

The Company's financial liabilities comprise borrowings, capital creditors, trade and other payables. The main purpose of these financial liabilities is to finance the Company's operations. The Company's financial assets include trade and other receivables, cash and cash equivalents, investments at cost/fair value and deposits.

The Company is exposed to market risk, credit risk and liquidity risk.

The Company's senior management oversees the management of these risks. The Board of Directors reviews and agrees policies for managing each of these risks, which are summarised below:

I) Market risk

Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises two types of risk: currency risk and other price risk, such as raw material and fuel price risk . Financial instruments affected by market risk include FVTPL investments, trade payables, trade receivables, etc.

(a) Foreign currency risk

The company undertakes transactions denominated in different foreign currencies primarily in USD and consequently exposed to exchange rate fluctuations. Exchange Rate exposures are managed within approved policy parameters. The carrying amounts of the company's foreign currency denominated monetary assets and monetary liabilities at the end of the reporting period are as disclosed under note no. 2.34 above.

Foreign currency sensitivity

The company is principally exposed to foreign currency risks against USD. Sensitivity of profit or loss arises mainly from USD denominated receivables and payables.

(c) Raw Material and Fuel Price Risk

The company is impacted by the price volatility of certain commodities like raw materials, packing materials and fuel. The Company is impacted by the price volatility of Fuels like Gas, Furnace Oil, etc. To minimize the risk related to fuel price change, the Company uses alternate fuel based on their market prices. The Company swaps and uses alternate fuels based on the cost of energy efficiency and, hence quantification of sensitivity is not practical. To mitigate the volatility in market price of major raw materials, the company has entered into fixed price contract.

II) Credit risks

Credit risk is the risk that counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. The Company is exposed to credit risk from its operating activities (primarily trade receivables).

Trade receivables

Credit quality of a customer is assessed based on an appraisal of each customer and individual credit limits are defined in accordance with this assessment and performance of the customer. Outstanding customer receivables are regularly monitored.

An impairment analysis is performed at each reporting date on an individual basis for all the customers. The maximum exposure to credit risk at the reporting date is the carrying value of trade receivables disclosed in Note 2.6. The Company has evaluated the concentration of risk with respect to trade receivables as low, as there is no single large customer creating significant risk.

III) Liquidity Risk

The Company's objective is to at all times maintain optimum level of liquidity to meet its cash and collateral rquirement at all times. The need of the funds of the company are being met by internal accrual and borrowings. The short and medium term requirements are met through the committed lines of credit.

2.43 CAPITAL MANAGEMENT

For the purpose of the Company's capital management, capital includes issued equity capital, share premium and all other reserves attributable to the equity shareholders of the Company. The primary objective of the Company's capital management is to maximise the shareholder value. The Company manages its capital structure and makes adjustments in line with changes in economic conditions. To maintain or adjust the capital structure, the Company may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares or sale assets to reduce debt. The Company monitors capital using a gearing ratio, which is net debt divided by total capital plus net debt. The company includes within net debt, interest bearing long term loans and borrowings less cash and cash equivalents The capital structure of the Company consists of Total Equity of Rs. -76635.63 Lakhs (Previous year Rs. -43167.33 Lakhs) (Refer Note No. 2.11 & 2.12).

GEARING RATIO:

The RP received claims amounting to Rs 3,33,810 lakhs from Financial Creditors till May 18, 2022 and after verification admitted a sum of Rs 3,32,818 lakhs as claims of Financial creditors having books balance of Rs 2,89,710 lakhs and claim of Rs 976 Lakhs from financial creditors is under verification and remaining amount of Rs 16 lakhs has been rejected. RP is still in the process of collating and verifying claims received from the various classes of operational/ others creditors totalling to Rs 26,444 lakhs out of which Rs 3363 lakhs has been rejected and Claim of Rs 20,515 Lakhs has been admitted and remaining amount of Rs 2,566 lakhs is under verification and shall account for the verified claims against the company as per the provisions of IBC 2016. Pending reconciliation of the claim admitted with the books of accounts, the impact of such claims, if any, that may arise has not been considered in the preparation of the aforesaid Financial Statements as on March 31, 2022
- **2.46** It may be further noted that in consonance with the stipulations contained in Section 14 of the Code, a moratorium has been declared vide the Order dated October 21, 2021 passed by the Hon'ble NCLT, inter alia, prohibiting the following:
 - a. the institution of suits or continuation of pending suits or proceedings against the Corporate Debtor including execution of any judgement, decree or other in any court of law, tribunal, arbitration panel or other authority;
 - b. transferring, encumbering, alienating or disposing of by the Corporate Debtor any of its assets or any legal right or beneficial interest therein:
 - c. any action to foreclose, recover or enforce any security interest created by the Corporate Debtor in respect of its property including any action under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002;
 - d. the recovery of any property by an owner or lessor where such property is occupied by or in the possession of the Corporate Debtor.
- **2.47** As a part of the CIRP, the RP has appointed BDO India LLP for conducting transaction audit as per section 43, 45, 50 and 66 of the Code.
- **2.48** As part of the ongoing CIRP process the RP has appointed, two (2) independent valuers to conduct the valuation of the assets of the Company and assets collateral held as securities as required under the provisions of the Code.
- **2.49** As per the provision of IBC 2016, the RP has initiated the resolution process for the Company by inviting expression of interest through publication of Form G on 25th March 2022. The company has received expression of interest from various applicants and currently the last date for submission of the resolution plan is 23rd July 2022.
- **2.50** There is NIL carrying balance or transaction occurred during the current year with the companies struck off by the Registrar of Companies.
- **2.51** None of the Loans or Advances in the nature of loans as at 31st March, 2022 and as at 31st March, 2021 are granted to promoters, directors, KMPs and the related parties (as defined under Companies Act, 2013,) either severally or jointly with any other person, that are: (a) repayable on demand or (b) without specifying any terms or period of repayment.
- **2.52** The company has used the borrowings from banks and financial institutions for the specific purpose for which it was taken at the balance sheet date.
- **2.53** All the Registration of Charges or Satisfaction of Charges with the Registrar of Companies are completed within the statutory period.
- **2.54** The company has complied with the number of layers prescribed under clause (87) of section 2 of the Companies Act read with Companies (Restriction on number of Layers) Rules, 2017.
- **2.55** The Company has not advanced or loaned or invested funds (either borrowed funds or share premium or any other sources or kind of funds) to any other person(s) or entity(ies), including foreign entities (Intermediaries) with the



understanding (whether recorded in writing or otherwise) that the Intermediary shall (i) directly or indirectly lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the company (Ultimate Beneficiaries) or (ii) provide any guarantee, security or the like to or on behalf of the Ultimate Beneficiaries.

- 2.56 The Company has not received any fund from any person(s) or entity(ies), including foreign entities (Funding Party) with the understanding (whether recorded in writing or otherwise) that the company shall (i) directly or indirectly lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Funding Party (Ultimate Beneficiaries) or (ii) provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries.
- 2.57 No transactions have been surrendered or disclosed, previously unrecorded in the books of accounts, as income during the year in the tax assessments under the Income Tax Act, 1961.
- **2.58** The Company has not traded or invested in Crypto currency or Virtual Currency during the current financial year.
- 2.59 The statements of current assets filed by the Company with banks or financial institutions are in agreement with the books of accounts.
- **2.60** The company has not been declared wilful defaulter by any bank or financial Institution or other lender.
- **2.61** Figures of the previous quarters/periods have been regrouped / re-arranged wherever considered necessary.
