With reference to our letter dated 7<sup>th</sup> January 2022, please note that the appeal filed against the Order of the Hon'ble NCLT, Kolkata Bench dated 21<sup>st</sup> October 2021 was heard by the Hon'ble National Company Law Appellate Tribunal, New Delhi (NCLAT) on 13<sup>th</sup> January 2022, wherein the Hon'ble NCLAT has inter alia, fixed the next date of hearing of the matter as 18<sup>th</sup> January 2022.

Further, the Hon'ble Tribunal directed that the directions given vide interim order dated 28<sup>th</sup> October 2021 shall remain in force till the next date of hearing i.e the Corporate Insolvency Resolution Process (CIRP) shall continue while the constitution of the Committee of Creditors (CoC) stands stayed.
