The Hon'ble National Company Law Tribunal (NCLT)- Kolkata Bench admitted, the application for initiation of Corporate Insolvency Resolution Process ('CIRP') under Section 7 of the Insolvency and Bankruptcy Code, 2016 ('IBC') which was filed by DBS Bank Limited, in its capacity as a Financial Creditor of the company before the vide its Order dated NCLT. October, 2021. Accordingly, Mr. Girish Siriram Juneja, having registration No. IBBI/IPA-001/IP-P00999/2017-18/11646, been appointed as Resolution Professional (RP) and the Committee of Creditors (CoC) has been formed. The RP has published the advertisement seeking Expression of Interest (EoI) from the prospective Resolution Applicants (PRAs) under the CIRP and subsequently notified the finals list of PRAs. Currently, the last date of submission of the Resolution Plan is fixed as 23rd July, 2022.

An appeal has been filed by one of the Promoter of the Company with Hon'ble National Company Law Appellate Tribunal (NCLAT), New Delhi against the aforesaid order of Hon'ble NCLT. The appeal was scheduled to be heard on 1st April, 2022. However, it could not be heard as the concerned Court was not in session on that day. The next date fixed for the hearing of the matter is 14th July, 2022.
